

6 Month Contract

Payment Terms and Conditions 6 month contract

Principle Terms

- The agreement starts as soon as both parties have signed.
- Membership starts on the membership start date.
- Membership is for a minimum period of 6 months from the membership start date.
- During the first 6 months of this agreement cancellation may only be considered as per the Fair Cancellation Policy below.
- Members are entitled to all rights and privileges for the type of membership chosen.
- This agreement is non transferable.

Fees and Charges (Direct Debit and Annual)

The fee relates exclusively to the use of the gym. All other activities associated with the membership are deemed to be an addition to the fee and are subject to change.

1. All payment for membership is due in advance as follows:
 - a. Annual membership Payment in full before commencement of membership
 - b. Monthly Direct Debit memberships A pro rata initial payment for the balance of the first month's membership followed by advance payments on the first day of each following month by Direct Debit.
2. Joining fee or initial payment is due and payable immediately before any facilities may be used. These payments are non refundable except in circumstances where:
 - a. There has been a breach or negligence by us or
 - b. On the valid exercise of your statutory cancellation rights.
3. All monthly membership payments shall be paid by Direct Debit and are payable monthly in advance.
4. A minimum of 6 monthly payments are required before this contract may be terminated including any initial pro rata payment. Once you have completed the 6 monthly Direct Debit payments you can cancel your automatic renewal payments by contacting your local Hello Fit and giving 30 days notice in advance. You should not cancel your Direct Debit mandate with the bank until the final month's payment has been drawn.

5. If you fail to pay any amount due under this agreement for a period of more than 30 days you will be denied access to the facilities until the amount due has been paid in full. We will implement Hello Fit debt management policy.
6. You agree to advise us promptly of any change to the member details provided.
7. Annual membership payments purchased at discounted rates are non refundable.
8. A member whose membership is terminated shall forfeit all the privileges of membership with immediate effect. There will be no entitlement to refund of any monthly membership charges already paid.
9. Monthly membership fees may be increased subject to 30 days notice at the discretion of Hello Fit.
10. For the avoidance of any doubt any member who re joins the centre following any previous period or periods of membership shall pay the appropriate joining fee for new members.
11. For members under 18 only third party payer the agreement to pay is with the person who gives consent to the membership. This must be the same person who makes the payment in full or initial payment and subsequent payments. It is the person over 18 who signs these terms and conditions and pays the membership fee that will be responsible for any breach of these terms and conditions. Members under 18 years of age have the right to cancel their membership anytime by contacting your local Hello Fit and giving 30 days notice in advance.

Membership Renewal

12. Annual membership is renewed for one year by payment of the membership fee in full in advance. For monthly Direct Debit memberships the membership continues on a rolling monthly Direct Debit payment after the initial 6 month period until cancelled by either party.
13. At the end of the first 6 months membership you may prevent automatic renewal at any time by giving 30 days notice in advance at your local Hello Fit. You should not cancel your Direct Debit mandate with the bank until the final month's payment has been drawn.
14. Members are required to provide further evidence to meet eligibility criteria in order to renew an annual or Direct Debit concession or corporate membership on a yearly

basis. If no evidence is provided the Direct Debit membership will renew automatically and convert to the standard price.

Fair Cancellation

15. Hello Fit operates a fair cancellation policy. Only under the following circumstances will we consider the cancellation of a membership within the first 6 months of a Direct Debit membership or annual membership.

16. Relocation This agreement may be cancelled if the member moves to a permanent address more than 15 miles away from the facility. A copy of a utility bill or bank statement showing the new address should be supplied in support of this.

17. Long term over 3 month illness or injury This agreement may be cancelled in the event of an illness injury or medical condition which in the opinion of a suitably qualified medical practitioner prohibits exercise for 3 months or longer. Appropriate proof must be provided.

18. Hardship This agreement may be cancelled where the member's financial circumstances have reduced to the extent where it makes it difficult to sustain the membership. Appropriate proof must be provided. Examples include redundancy or loss of employment or breakdown of relationship where a two income household reduces to a single income.

19. Pregnancy This agreement may be cancelled upon receipt of appropriate written proof being given.

20. Breach This agreement may be cancelled if Hello Fit is in breach of contract including not providing facilities or services which may reasonably be expected by the member or where standards fall below those detailed in the membership terms and conditions.

21. Hello Fit may also terminate this agreement with immediate effect on notice to the member if there is a breach of Gym Rules such as theft or other criminal activity within the facility.

22. A membership cancellation will not be implemented until the appropriate evidence is provided by the customer and received in writing or via email by Hello Fit giving 30 days notice in advance.

Freezing

23. No membership freeze will be implemented until the appropriate evidence is provided by the customer and received in writing or via email by Hello Fit.

24. Temporary illness or injury This agreement may be frozen in the event of a temporary illness injury or medical condition which in the written opinion of a doctor or other suitably qualified medical practitioner prohibits exercise for a period of time. This should be submitted inside 30 days of the situation arising.

25. A membership may be frozen for a minimum of one month and up to a maximum of three months at any one time.

- A. A membership may be frozen for up to three months within a one year period from the Direct Debit start date.
- B. If the membership freeze period exceeds 3 months the membership may be terminated in agreement with Hello Fit and the member.

26. A membership freeze period does not affect the minimum number of Direct Debit payments or the length of membership purchased. Any Direct Debit payments remaining at the time of the freeze will recommence on a monthly basis at the end of the freeze period. For annual memberships the freeze period will be added on to the end of the original 6 month period where applicable.

27. Extension of freeze period 30 days before the end of the initial freeze period further evidence must be provided by the customer to Hello Fit together with a request to extend the freeze period.
